Dear Mr Aguilar,

The Conservation and Management Measure on Cooperating Non-Members (CMM 2009-11) tasks the Executive Director to forward a copy of the relevant TCC recommendations and advice to non-member applicants for Cooperating Non-Member (CNM) status following TCC12.

Cooperating Non-Member Requests

TCC12 in considering the applications from non-members for CNM status in 2017 reached the following recommendations:

- (a) TCC12 has reviewed your countries CNM request for 2017 and the application has been forwarded to WCPFC13 for consideration.
- (b) TCC12 noted with appreciation the attendance and participation of Ecuador, El Salvador, Liberia, and Vietnam at this year's meeting and encourages other CNM applicants to attend TCC meetings in the future.
- (c) TCC12 noted that during the SWG three CNM applicants (Ecuador, El Salvador and Vietnam) have reiterated interest in becoming full Commission members and that WCPFC13 consider whether to invite them to become members. El Salvador has made its request in a formal letter to the WCPFC Secretariat.
- (d) TCC12 noted that all CNM applicants other than Mexico and Vietnam made a financial contribution and notes Vietnam's statement that payment was made over the course of TCC12. TCC12 recommended that Mexico consider the prospect of a voluntary payment in advance of WCPFC13.

- (e) TCC12 noted the following gap or issue in the application for Cooperating Non-Member status and encourages applicants to rectify them if possible by WCPFC13
“Mexico – TCC12 noted that it is not clear whether Mexico has provided a commitment to make a financial contribution. TCC12 further noted that Mexico has not made an explicit commitment to accept High Seas Boardings and Inspections and that Mexico considers this requirement as not applicable.”
- (f) Furthermore, TCC12 recommended that WCPFC13 take into consideration the Compliance Status of all CNM applicants in making its decision on the CNM applications and participatory rights.

Please find attached to this letter for your review and consideration prior to WCPFC13 Attachment 1 which include relevant advice and recommendations from the draft summary report of the Twelfth Regular Session of the WCPFC Technical and Compliance Committee on CNM applications.

We would suggest that where possible these should be provided to the Secretariat before **Friday 4th November**, so that other CCMs can consider your information in advance of WCPFC13.

AGENDA ITEM 4 — CNM REQUESTS

TCC12 established a small working group led by New Zealand to develop draft recommendations and technical advice for the applications for CNM status for 2017 (WCPFC-TCC12-2016-09_rev1) and bring recommendations back to the plenary during TCC12. The Compliance Manager advised that requests for the granting of CNM status in 2017 had been received from the seven current CNMs (Ecuador, El Salvador, Liberia, Mexico, Panama, Thailand, and Vietnam). All the applications were submitted using the electronic PDF form, and the documentation had been made available to members through the secure section of the website. Financial contributions by the applicants were also detailed. As it had for other full members of the Commission, the Secretariat had prepared draft CMRs for the CNMs, and these would be reviewed at TCC12. It was noted that Ecuador, Vietnam, El Salvador and Liberia were present at TCC12.

The TCC Chair noted that TCC's role was not to make final determinations on CNM status — that was a matter for the Commission — but to review the applications. The TCC Chair also clarified that the working group's scope was not to consider applications which had been made for full membership: in past years TCC had noted requests for full membership but had not evaluated them.

On 27 September, the small working group came back to plenary. S. Tau (New Zealand) thanked the group for its work assessing the CNM applications for 2017, and the CNM applicants that were at TCC12 and had assisted the process. The TCC Chair noted the efforts of the group and thanked them for their work.

TCC12 provided the following decisions and recommendations to WCPFC13:

- a. TCC12 has reviewed the following CNM applications and is forwarding them to WCPFC13 for consideration: Ecuador, El Salvador, Liberia, Mexico, Panama, Thailand, and Vietnam.
- b. TCC12 thanked the Secretariat for the development of the CNM application template which assisted the process greatly and thanks CNM applicants for using the template in submitting their applications.
- c. TCC12 noted with appreciation the attendance and participation of Ecuador, El Salvador, Liberia, and Vietnam at this year's meeting and encourages other CNM applicants to attend TCC meetings in the future.
- d. TCC12 noted the CNM working group process occurred in parallel with the compliance monitoring scheme process and recommended that following TCC12, in consultation with SPC, the Secretariat write a particularised letter to CNMs outlining any identified deficiencies in data provision and request that CNM applicants provide any information outlined in these letters, as requested during the CMS process, 30 days in advance of WCPFC13, and that these letters and any responses be assessed by WCPFC13.
- e. TCC12 recommended that WCPFC13 take into consideration the Compliance Status of all CNM applicants in making its decision on the CNM applications and participatory rights.
- f. TCC12 noted that all CNM applicants other than Mexico and Vietnam made a financial contribution and notes Vietnam's statement that payment was made over the course of TCC12.

g. TCC12 recommended that Mexico consider the prospect of a voluntary payment in advance of WCPFC13.

h. TCC12 notes that during the SWG three CNM applicants (Ecuador, El Salvador and Vietnam) have reiterated interest in becoming full Commission members and that WCPFC13 consider whether to invite them to become members. El Salvador has made its request in a formal letter to the WCPFC Secretariat.

i. TCC12 recommended that the template for CNM applications be amended to include a field to indicate whether the CNM wishes to become a full Commission member.

j. TCC12 noted the following gaps or issues in the applications for individual applicants and encourages applicants to rectify them if possible by WCPFC13:

- Ecuador – TCC12 noted that Ecuador provided its Annual Report Part 1 during TCC12 and that Annual Reports form a fundamental part of the Commission process. TCC12 recognised the domestic circumstances in Ecuador which contributed to this late provision. TCC12 encouraged Ecuador to provide its Annual Report Part 1 on time in the future.
- Liberia – TCC12 noted that Liberia did not provide its Annual Report Part 1 and that Annual Reports form a fundamental part of the Commission process. TCC12 recommends that Liberia provide its Annual Report Part 1 a minimum of 30 days in advance of WCPFC13. TCC12 notes that Liberia's application was submitted late.
- Mexico – TCC12 noted that it is not clear whether Mexico has provided a commitment to make a financial contribution. TCC12 further noted that Mexico has not made an explicit commitment to accept High Seas Boardings and Inspections and that Mexico considers this requirement as not applicable.
- Panama – TCC12 noted that Panama did not provide its Annual Report Part 1 and that Annual Reports form a fundamental part of the Commission process. TCC12 recommended that Panama provide its Annual Report Part 1 a minimum of 30 days in advance of WCPFC13.
- Thailand – Thailand has indicated that it has not provided full historical data on fisheries activities in the Convention area pursuant to CMM 2009-11 (2)(d). Applicants for CNM status are required to include in their requests full data on its historical fisheries in the Convention Area, including nominal catches, number/type of vessels, name of fishing vessels, fishing effort and fishing areas, pursuant to CMM 2009-11(2)(d). TCC12 recommended that Thailand provide this information a minimum of 30 days in advance of WCPFC13.
- Vietnam – TCC12 noted that Vietnam's financial contribution had not yet been received during TCC12 but that Vietnam made a statement that payment was pending.

2016 PROVISIONAL COMPLIANCE MONITORING REPORT rev1¹
(COVERING 2015 ACTIVITIES)
Executive Summary

I. INTRODUCTION

1. TCC12 undertook its sixth annual review of compliance by CCMs against a priority list of Commission obligations agreed to at WCPFC12 for 2016 – 2018 (Paragraphs 469 and 471 and Attachment O to WCPFC12 Summary Report).
2. TCC12 conducted its review in accordance with the revised Compliance Monitoring Scheme (CMS) adopted at WCPFC12 – CMM 2015-07.
3. Unlike past versions of the CMS, the current CMS does not require an overall assessment of each CCM, but only asks TCC to identify a compliance assessment for each specific obligation.
4. In accordance with Annex I of the CMS, the following statuses were considered in making the assessments: Compliant, Non-Compliant, Priority Non-Compliant, Capacity Assistance Needed, Flag State Investigation and CMM Review.

II. DEVELOPMENT OF THE PROVISIONAL COMPLIANCE MONITORING REPORT BY TCC12

5. TCC12 reviewed the draft Compliance Monitoring Report (draft CMR) for thirty seven (37) CCMs and one (1) collective group of Members in a closed working group session. The draft CMR is classified as non-public domain data and a number of CCMs were not able to agree to release their non-public domain data, therefore the decision was made to close the session. There continues to be interest among some CCMs and the Observers (who are not able to attend the closed session) in finding a way to address the confidentiality concerns of CCMs, and some CCMs would like to invite WCPFC13 to find a solution to this situation as a matter of urgency. It was noted that such efforts must begin either at the Commission meeting or well in advance of TCC, and will likely not get resolved if only raised just prior to TCC each year.
6. TCC12 notes that the Provisional CMR provides its provisional compliance assessment and it is submitting this report to the Commission for its consideration and final assessment in accordance with para 31 of CMM 2015-07.

III. ISSUES ARISING DURING THE COMPLIANCE REVIEW PROCESS

7. TCC12 noted that the new statuses of Investigation Status and Capacity Assistance Needed were helpful in progressing our assessment of CCMs' compliance related relevant obligations.
8. As this was the first year that we used these new statuses, TCC12 agreed to be flexible in its approach to assessing these statuses and even when complete information was not provided in accordance with CMM 2015-07, TCC12 allowed CCMs to supplement information across the floor.

9. TCC12 noted that paragraphs 5 and 8 of CMM 2015-07 provide specific information that is required for a Capacity Development Plan (para 5) and Investigation Status Report (para 8). Some CCMs provided detailed information in their dCMR responses and/or in the WCPFC compliance case file system, while other CCMs provided more general information in their reports or across the floor.

10. TCC12 reminds CCMs of the requirements in CMM 2015-07 paragraphs 5 and 8 to submit Capacity Development Plans or Investigation Status Reports, where appropriate, 28 days prior to TCC in their dCMR responses, and recommends that this information be provided in writing to improve TCC's ability to make informed assessments.

11. TCC12 noted that CCMs should provide information on each alleged violation or investigation, so that TCC can fully understand the status of each investigation, rather than providing summary information related to all alleged violations. Some CCMs also noted that when closing investigations, CCMs should provide the reason(s) those investigations were closed.

12. TCC12 agreed that for paragraphs 5 and 8 a paper template, might assist CCMs in providing the required information and recommends that such a template be developed by the Secretariat.

13. In accordance with paragraph 29 of CMM 2015-07, where there were majority/minority views on the provisional assessment, TCC12 took the majority view as the provisional assessment and noted the minority view. TCC12 notes the following assessments with majority/minority views for the Commission for its final assessment:

a. CMM 2014-01, para 14 – The majority view was that China, Federated States of Micronesia, and Kiribati all should be assessed as compliant, however, there was a minority view that these CCMs should be assessed as Non-Compliant with this obligation. The difference of view related to the interpretation of footnote 2 of the measure.

b. CMM 2014-01, para 16 – The majority view was that China should be assessed as Non-Compliant, however, there was a minority view that China should be assessed as Compliant with this obligation. The difference of view related to whether footnote 3 applies to vessels under charter.

c. CMM 2014-01, para 25 – The majority view was that China should be assessed as Priority Non-Compliant, however, there was a minority view that China should be assessed as Compliant with this obligation. The difference of view related to whether vessels under charter could fish those days on the high seas. TCC12 noted there was some discussion of the relationship between para 5 and para 25.

d. SciData 03 – The majority view was that Chinese Taipei should be assessed as Priority Non-Compliant, however, there was a minority view that Chinese Taipei should not be assessed for this obligation. The difference of view related to what constitutes the obligation to submit data under SciData 03.

14. TCC12 is pleased to note that it was able to complete an assessment for all obligations identified for assessment in 2016.

15. Consistent with the 2012, 2013, 2014 and 2015 Final Compliance Monitoring Reports, CCMs evaluated as other than “compliant” for obligations are strongly encouraged to address their implementation issues.

IV. ISSUES RELATED TO SPECIFIC CMMs OR OTHER OBLIGATIONS

16. For CMM 2007-01, Attachment K, Annex C, para 6, China requests that SC13 complete the tasking related to the required metric for assessing observer coverage that was requested by WCPFC11.. Some CCMs stated that assessment of observer data provision is not covered under this paragraph.

17. For CMM 2008-03, para 7, there were extensive discussions on the specific requirement of this paragraph and several issues were raised that would benefit from further discussion and/or proposals for consideration at WCPFC13:

- a. What is the difference, if any, between to “fish for” and to “target” a species?
- b. There was discussion regarding the broad definition for “shallow-setting” contained in the measure.
- c. It was noted that this measure is fairly old and suggested that consideration should be given as to whether the measure should be updated.

18. For our assessment this year, TCC12 applied a strict application of the language in CMM 2008-03, para 7, and found the obligation not applicable to CCMs if they confirmed that they did not have “longline vessels that fish for swordfish in a shallow-set manner” based on the exact language in the measure.

19. In our assessment of CMM 2013-08, paragraph 1, China was assessed as Investigation Status but requested a note indicating that it will be unable to investigate any further without being provided further evidence.

20. Questions related to the respective obligations of the flag state and chartering state came up in several discussions, primarily around CMM 2014-01. TCC12 noted that this issue would benefit from further discussion at the Commission.

21. Some CCMs raised the question in a couple of discussions as to whether the obligation to provide observer data is the responsibility of the flag CCMs or the observer provider.

22. TCC12 noted that although paragraph 16 of the CMS CMM (2015-07) requires that we address “compliance by CCMs with recommendations adopted pursuant to the Scheme the previous year,” we have not implemented this requirement of the review.

23. TCC12 recommends that the Commission discuss how para 16 of the CMS CMM (2015-07) can be implemented.

24. TCC12 noted that although we assessed whether Annual Reports were submitted on time, we did not assess whether Annual Reports were submitted at all. We noted that there was some ambiguity in the language of the measure on this point.

25. TCC12 recommends that the Commission agree that in future assessments, we will assess, separately, whether Annual Reports-Parts 1 and 2 have been submitted.

V. REQUESTS FOR ASSISTANCE AND CAPACITY BUILDING

26. Several areas were noted where targeted assistance is required to assist SIDS and other CCMs in implementing specific obligations.
