Compliance Monitoring Report update

Dear All

28th July was the deadline in CMM 2011-06 for the Executive Director to transmit the relevant section of the Draft Compliance Monitoring Report (draft CMR) to each CCM. As advised in WCPFC Circular 47, the majority of Annual Report Part 1 and Annual Report Part 2 were not received by the WCPFC8 agreed deadline (7th July and 1st July respectively). The non-receipt of the Annual Reports, which is the principal source of information for draft CMRs, has limited the ability of the Secretariat to generate draft CMRs for all CCMs by the deadline, and this has limited the time available for CCMs to respond. (28 August).

The following CCMs Annual Reports were received in time, and these CCMs have received a draft CMR by 28th July, the CMM 2011-06 deadline:

- Australia
- Belize
- El Salvador
- New Caledonia
- New Zealand
- Chinese Taipei
- United States of America

The following CCMs provided one or both Annual Reports after the deadline, and the Secretariat sent these CCMs their draft CMR sections on 3rd August:

- Canada
- European Union
- Federated States of Micronesia
- Fiji
- French Polynesia
- Indonesia
- Japan
- Republic of Korea
- Nauru

The Secretariat will within the week (by 16th August) send out draft CMRs to the following CCMs, who provided their outstanding Annual Report Part 1 or Part 2 report by the first week of August:

- Cook Islands
- Philippines
- Tonga
- Vietnam

For the remaining CCMs, one or both Annual Report Part 1 and Part 2 covering 2011 activities remain outstanding. As at today, nine Annual Report Part 1 and sixteen Annual Report Part 2 remain outstanding. (Annex 1 lists outstanding Part 1 and Part 2 reports by CCM). We ask that the seventeen CCMs with one or both outstanding Annual Reports submit these, with a copy to contact.ar@wcpfc.int as soon as practicable. In the meantime, the Secretariat is making best efforts to develop first draft CMRs for remaining CCMs, in the absence of these reports.
