Regarding Korea's Compliance Monitoring Reprort, Korea wish that the Secreatiat could consider following information on regarding three potential issues and make a correction in the CMR accordingly.

1. CMM 2009-06 11 "The number of transhipment"

- Current Summary of Issue : Report inconsistent

- Secretariat Explanation : inconsistent with the number of transhipment(CCM AR Pt 1 and Secretariat)

There was no transhipment between OYANG NO.355 and SEIWA on 16th January 2016. Please refer to attached Korea's 2016 transhipment data(see data field highlighted in red) Also. two transhipment cases omitted in the supporting documentation file provided by Secretariat. Two cases are highlighted in yellow in the attachment as well.

The final number of transhipment are : Offloading vessels : 78, Receiving vessels : 95. Therefore, please change the status of summary issue to "No issue detected".

2. CMM 2009-06 35 a (iii) "Transhipment pre-notification time frame"

- Current Summary of Issue : Late submission

- Secretariat explanation : All 2016 notifications were received however, 1 receiving vessel(carrier) and 2 offloading vessel(longliner notifications were received past the deadline)

In case of ORYONG NO.712, transhipment notification was made 38h47m before the transhipment. (the notification was submitted at 01:43(GMT) on Nov 7, 2016 / the transhipment began at 16:30(GMT) on Nov 8, 2016)

3. CMM 2009-06 35 a (iii) "Reporting including with respect to implementation of measures for non-target species"

The Secretariat requested detailed information on False Killer whale, however the information has been already provided to the Secretaritat. Please refer to the attached Korea's operational data (see "PS discard/release")
