**ANNUAL REPORT ON THE EASTERN HIGH SEAS POCKET (EHSP) SPECIAL  
MANAGEMENT AREA**

**Purpose**

1. This paper provides the annual summary report on activities in the EHSP Special Management Area (EHSP-SMA) based on data held by the Secretariat.<sup>1</sup>
2. The EHSP-SMA is the area of high seas bounded by the Exclusive Economic Zones (EEZ) of the Cook Islands to the west, French Polynesia to the east and Kiribati to the north.

**Review of available data relevant to CMM 2016-02**

*Vessel Sightings*

3. Paragraph 2 of CMM 2016-02 encourages vessels to report sightings of any fishing vessel within the EHSP-SMA to the WCPFC Secretariat. During the reporting period, the Secretariat did not receive any sighting reports from flag CCMs.<sup>2</sup>

*VMS*

4. **Figures 1 a.** and **b.** below summarise the number of vessels by gear type and by flag respectively, that reported entry/exit alerts for the EHSP through the WCPFC VMS for each month of 2019 to July 2020. These figures indicate the primary activity in this pocket is longline fishing mainly focused between March/April and October with a marked reduction in activity in December and January. **Annex 1** summarises the numbers of Entry and Exit Alerts generated by the Commission VMS.

5. **Annex 2** lists the 130 vessels (**111 longliners, 2 purse seiners, 1 pole and line, 8 carriers and 8 bunkers**) flagged to 8 CCMs (China, Cook Islands, Fiji, Liberia, Panama, Chinese Taipei, United States and Vanuatu) that were reporting to the WCPFC VMS from the EHSP during 1 January 2019 – 31 July 2020.

#### *Live List*

6. The Secretariat maintains a ‘live list’ of all fishing vessels in the EHSP in the secure page on the WCPFC website<sup>3</sup>. Vessels detected on VMS in the EHSP are displayed in a table as well as in a map of the EHSP in the EHSP page on the website. Vessels in the list are also directly linked to the WCPFC RFV, providing users with the ability to easily access vessel details. A sample screen shot of the ‘live list’ is shown in **Figure 2** below. CCMs can log into the EHSP secure page to view the latest data (<https://www.wcpfc.int/eastern-high-seas-pocket> ).

#### *Transshipment*

7. During the reporting period, there was no reported transshipment in the EHSP. CMM 2016-02 prohibited all transshipment activities in the EHSP from 1 January 2019.

#### *Compliance*

8. During the reporting period, there were no findings of alleged infringement by vessels occurring in the EHSP-SMA from high seas boarding and inspection activities or aerial surveillance activities that were reported to the Secretariat.

### **Review of CMM 2010-02 implementation by applicable CCMs under the Compliance Monitoring Scheme (CMS)**

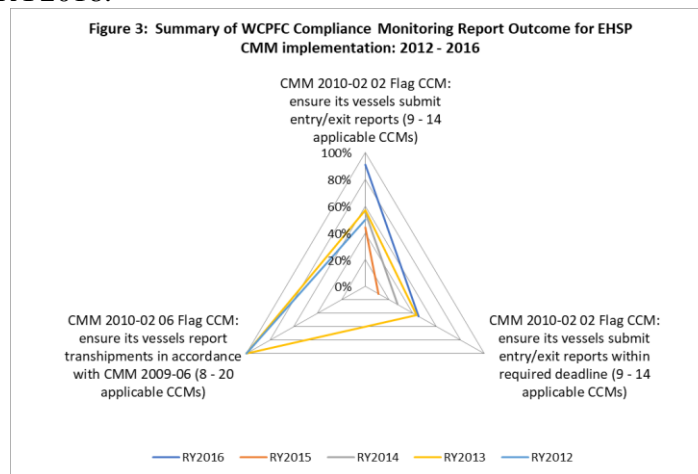
9. **Figure 3** below provides an overview of the result of the evaluation of CMM 2010-02 under the CMS over the years. CMM 2010-02 was evaluated annually between 2013 (for Reporting Year 2012) and 2016 (for Reporting Year 2015).

10. **Figure 3** shows that there were ongoing implementation issues faced by applicable CCMs in meeting the required entry and exit manual reports under CMM 2010-02 when vessels entered and exited the EHSP-SMA. In RY 2012 less than 50% of the flag CCMs who were expected to have provided entry and exit reports for their vessels were evaluated to have fully implemented this reporting obligation. Overtime there was improvement in the levels of implementation, however in RY 2016 around 90% of the applicable flag CCMs were assessed as fully implementing the reporting obligation.

11. It should be noted that CMM 2016-02 that applied in RY2017 and RY2018 no longer requires that flag CCMs ensure that their vessels submit entry/exit reports to the Commission at least 6 hours prior to entry/exit into the EHSP. Note CMM 2016-02 was not evaluated through the CMS in RY2017 or RY2018.



12. While **Figure 3** above provide an overview of the result of the evaluation of the EHSP CMM over the years, **Annex 3** provides a closer look at each obligation/paragraph related to the EHSP that were assessed and how CCMs have performed under the CMS for the years reporting was required (RY 2012 - RY 2015).

### Secretariat Observations

13. Members have worked to achieve 100% implementation of the EHSP CMM however, the data held by the Secretariat still shows that, while vessels are reporting their entry notifications, there are still slightly less exit notifications.

### Recommendation

14. TCC16 is invited to note the report and discuss the activities in the EHSP-SMA.
