# Mid-Term Evaluation of Western Pacific East Asia – Improved Tuna Monitoring Activity

The Western and Central Pacific Fisheries Commission was established to ensure, through effective management, the long-term conservation and sustainable use of highly migratory fish stocks in the western and central Pacific Ocean. The Commission's Secretariat which is located in Pohnpei, Federated States of Micronesia now invites applications for the consultancy to undertake a mid-term evaluation of the Western Pacific East Asia - Improved Tuna Monitoring Activity.

Recognising the importance to the WCPFC of continuing to improve tuna data from these Vietnam, Indonesia and the Philippines, the Government of New Zealand is providing NZD 4.91 million over 6 years for the Western Pacific East Asia Improved Tuna Monitoring (WPEA-ITM) Activity. The goal of the WPEA-ITM is to improve monitoring and management of tuna catches in Indonesia, Philippines and Vietnam and contribute to reduced Illegal, Unreported and Unregulated (IUU) fishing.

The WPEA-ITM Activity is being managed by the WCPFC Secretariat, working closely with the national fisheries authorities in the three countries, and with the Secretariate of the Pacific Community playing a critical implementation role.

The key objective of the mid-term evaluation is to inform the design and implementation of a possible future phase of the project. The mid-term evaluation will consider the progress of the WPEA-ITM activities, and identify possible changes or improvements based on the Activity's experiences so far.

### About this document

This document specifies the terms of reference for the mid-term evaluation of an Activity in the fisheries sector.

The document guides the Western and Central Pacific Fisheries Commission (WCPFC) and Respondents in the procurement of the services required by MFAT to evaluate the New Zealand Aid Programme Activity *Western Pacific East Asia - Improved Tuna Monitoring* (Activity).

### **Goals and Outcomes**

The key objective of the evaluation is to inform the design and implementation of a possible future phase of the project.

This will be done by assessing the project with reference to the six Development Assistance Committee (DAC) criteria for evaluation<sup>1</sup>, with the addition of gender and social inclusion.

- 1) Relevance
- 2) Coherence
- 3) Effectiveness
- 4) Efficiency
- 5) Impact
- 6) Sustainability
- 7) Gender and social inclusion

A list of indicative evaluation questions is included in Appendix A.

The mid-term evaluation will consider the progress of the WPEA-ITM activities against the Activity Results Framework (Appendix C), and

identify possible changes or improvements based on the Activity's experiences so far. The results of the evaluation will be reported to the Activity project team, WCPFC Secretariat, and MFAT, national implementing agencies that are involved in the Activity and may be disseminated to other key stakeholders.

#### Scope of the Evaluation

The evaluation will cover the period from December 2016 to December 2020. The geographic focus will be the East Asian countries that participate in the project, Indonesia, Philippines and Vietnam. The target groups are the key implementing agencies in the three partner countries, SPC scientists, the WCPFC Secretariat, and NZ MFAT staff who have been involved with the Activity.

The mid-term review shall be conducted against the Activity Results Framework, and provide recommendations on any improvements needed to update the existing workplan and targets in the Activity Results Framework. The review should also assess the level of country ownership, progress with the exit strategy, and the use of any savings for related and prioritised work that is not part of the Activity Design Document (ADD).

- Comply with the requirements of the New Zealand Aid Programme policies on Activity Quality, Activity Planning, Activity Implementation, and cross-cutting issues (see <u>NZ MFAT Tools and</u> <u>Guides</u>);
- Demonstrate good value for money in line with the New Zealand Aid Programme's Value for Money Guideline; and
- Comply with the requirements of the New Zealand Aid Programme's <u>ADD template</u>.

#### Background

#### Brief history of the programme/Activity

The tuna fisheries in the Pacific Ocean waters of Indonesia, the Philippines and Vietnam represent around 30% of the annual catches of key tuna species in the Western and Central Pacific Ocean. The lack of accurate data on catch, effort and the composition of catches in these waters has been highlighted as a key uncertainty in stock assessments at the Western and Central Pacific Fisheries Commission (WCPFC) for a number of years.

In an effort to improve understanding of these fisheries and increase the accuracy of data available for stock assessments, a series of projects have been implemented since 2000 to support data collection in Indonesia, Philippines and Vietnam. These projects have included the Indonesia and Philippines Data Collection Project (IPDCP), the West Pacific East Asia Oceanic Fisheries Management Project (WPEA-OFM), and the Sustainable Management of Highly Migratory Fish Stocks in the West Pacific and East Asian Seas (WPEA-SM). The WPEA-SM project, implemented by the WCPFC Secretariat and the UNDP, working closely with national project coordinators in the three countries, terminated on 27 April 2019.

Since these projects were first instituted in 2000, significant progress has been made on data collection, data analyses and verification, and the provision of catch estimates. Consequentially, the uncertainty in WCPO tuna stock assessments associated with tuna data in these three countries has been reduced.

Recognising the importance to the WCPFC of continuing to improve tuna data from these three countries, the Government of New Zealand is providing NZD 4.91 million over 6 years for the Western Pacific East Asia Improved Tuna Monitoring (WPEA-ITM) Activity. The goal of the WPEA-ITM is to improve monitoring and management of tuna catches in Indonesia, Philippines and Vietnam and contribute to reduced Illegal, Unreported and Unregulated (IUU) fishing.

The WPEA-ITM Activity is being managed by the WCPFC Secretariat, working closely with the national fisheries authorities in the three countries, and with SPC FAME playing a critical implementation role.

The WPEA-ITM Activity commenced in 2017, but the full implementation of planned activities were delayed due to capacity constraints associated with the cross over with the WPEA-SM project and administrative delays. However, since April-May 2019, when the MOUs between WCPFC and the three countries were completed and the WPEA-SM project wrapped up, implementation of the WPEA-ITM activities has gathered momentum. The Activity is currently scheduled to end in March 2023.

- 1: Relevance
  - How relevant is the Activity to the priority needs of the partner countries (WPEA region) and the Commission (WCPO region) in relation to tuna fisheries data collection, monitoring and management?
  - Is there a need to review the program theory and adapt the workplan for future years based on new emerging priorities (since project design in 2016)?
- 2: Coherence
  - How well does this Activity fit with WCPFC priorities?
  - To what extent is this Activity coherent with other New Zealand Aid Activities?
- 3: Effectiveness
  - What progress has been made against the outputs and short and medium term outcomes described in the Results Diagram? What are major factors that have affected the achievement of results?
  - What (if any) unintended outcomes (positive and negative) were there? Why?
- 4: Efficiency
  - Have outputs been achieved in a timely manner? If yes/no why?
  - Could similar outputs be achieved with fewer funds or in a different way?
  - Were there any impacts on the efficiency in achieving the outputs due to the COVID-19 pandemic situation?
- 5: Impact
  - What positive and negative medium and long term impacts at the national and regional levels have resulted, or could result, from the Activity?
  - What would happen without the Activity or a similar scheme st the national and regional levels?
- 6: Sustainability
  - What critical success factors, including doner support, are in place to maintain the provision of critical services and activities beyond the life of this Activity?
  - Considering catch reporting is the obligation of WCPFC members, cooperating non-members and participating terrirories, what, if anything, needs to be changed to ensure sustainability of the current services offered by the three countries?

# Appendix B: Reporting Requirements

#### **Evaluation Plan**

The evaluator/team will develop an evaluation plan in consultation with the WCPFC Secretariat and Project Manager. The intended results of the activity/programme (i.e. the goal, outcomes and outputs) will be clarified and described in a results diagram (program logic, logic model) in the evaluation plan. The plan may need to be redrafted if it does not meet required standards or is unclear. The evaluation plan must be approved prior to the start of any fieldwork or other substantive work. The evaluation plan is to be appended to the main written report.

It is anticipated that the evaluation plan will identify how the information needs can be met through current documentation (including undertaking documentary analysis), and/or what information gaps will remain due to the inability to undertake incountry fieldwork at this time. Data collection methods, for example, in-depth interviews, focus groups, direct observation and case studies should be outlined. Research ethics including but not limited to risk, confidentiality and voluntary participation must be considered and addressed within the evaluation plan. Evaluation plan templates can be found on the <u>MFAT Tools and Guides</u> webpage.

#### **Mid-Term Evaluation Report**

The evaluation report must meet quality standards as described in the <u>Evaluation Policy for the New Zealand Aid Programme</u> and should not be longer than 25 pages. The report must include a one to two page evaluation summary written in plain and simple language.

The mid-term review shall be conducted against the Activity Results Framework, and provide recommendations on any improvements needed to workplan and targets. The review should also assess the level of country ownership, progress with the exit strategy, and the use of any savings for related and prioritised work that is not part of the ADD.

The findings, conclusions and recommendations must be based on clear evidence presented in a way that allows readers to form their own views on the validity and reliability of the findings, including assessing the vested interests of sources. Where there is conflicting evidence or interpretations, the report should note the differences and justify the findings.
