With reference to the e-mail of 26 November 2008, in which it attached a letter dated 25 November 2008 from Hon. M.C. Mitchell, Secretary of Cook Islands Ministry of Foreign Affairs and Immigration to you, in your position as Chairman of the WCPFC, informing, among other things, that Cook Islands notified the Commission that, pursuant to paragraph 6 of CMM 2006-08, Cook Islands shall apply the WCPFC High Seas Boarding and Inspection Procedures in their entirety as between the Cook Islands and Chinese Taipei.

In reply, I have the honor to state the following:

1. In accordance with the WCPFC High Seas Boarding and Inspection Procedures as well as the said correspondence, from Cook Islands dated 25 November 2008, the WCPFC Boarding and Inspection Procedures have applied in their entirety as between Cook Islands and Chinese Taipei.
